ADVANCING TRADE FOR U.S. LIVE ANIMALS AND GENETICS

Trade policy advances are critical to U.S. agriculture's success in the global export arena. Since USDA first established a stand-alone mission area focusing on trade and international affairs in 2017, USDA's Trade and Foreign Agricultural Affairs has made significant advances to support U.S. agriculture.

JOBS AND ECONOMIC GROWTH

U.S. food and agricultural exports support more than **one million** jobs and generate more than **\$200 billion** in additional economic activity each year in rural communities and beyond.

VALUE OF EXPORTS AND TRADE PRESERVED

In 2023*, the actions of USDA's Foreign Agricultural Service helped preserve **\$6.4 billion** in total U.S. agricultural exports. That year, exports of U.S. live animals and genetics were valued at **\$1.9 million**.

EXPORT PROMOTION SUPPORT

In 2024*, USDA export promotion programs (such as the Foreign Market Development Program, Market Access Program, and Regional Agricultural Promotion Program) provided more than **\$6.9 million** to the U.S. agricultural industry to support and grow exports of U.S. live animals and genetics.
